 - b) **Area LALC Meeting** Cllr Robinson attended 241st Meeting. Adoption of Local Plan was discussed, Head of Planning at Wyre attended, David Thow to provide feedback. It was fed back that the Wyre building rate was to reduce to 313 per year from 400. The Star Council Awards were announced, it was highlighted that the Spring Conference was in June and the date of next meeting was last Wed in July.

9. **2019/20May/09 Bob Williamson Park:**
 - a) Park Sub-committee: Update was provided, work was ongoing on pond, paths and drainage. Following a request from the public, it was resolved that Andrew Parkinson be asked to include an extra path from the back of the park to the existing path within the dog exercise area and a drop kerb from the new path into the car park
 - b) Anti-social use of park by small minority of dog owners – Clerk to continue discussions with WBC and potentially involve school. It was resolved that Clerk includes warning within publicity entries.
 - c) Working group 11th May – It was resolved that the group would work clearing around the pond area.
 - d) Gym Equipment: It was resolved that the Clerk arrange to re-raise application for Grant following community consultation.

 - f) Daily locking of park – volunteers had not attended meeting therefore no further action.
 - g) Reapplication for use of Park by football team – It was resolved that the application be agreed.
